In accordance to Directorate letter No. A-34012/05/2018-DE dated 27.07.2018, it is to inform that the Limited Departmental Competitive Examination for Lower Grade Officials for promotion to the cadre of Postal Assistants/Sorting Assistants from Postman/Mailguard, Despatch Riders and MTS cadres for the vacancies of the years 2016-17, 2017-18 and 2018 (upto 31.12.2018) under Departmental quota will be held on <u>09.12.2018</u> (Sunday).

#### 2. Eligibility Criteria:

2.1 As per the Revised Recruitment Rules notified vide Directorate letter No. 4-5/2015-SPB-I dated 05.06.2015, 50% of the PA/SA vacancies in Post Offices and Mail Offices are to be filled up by promotion through a Limited Departmental Competitive Examination. #### 3. Pattern and Syllabus:

3.1 The revised pattern and syllabus has already been circulated vide Directorate letter No.60-10/2011-SPB-I dated 10.03.2011 and the same is indicated below for reference. The Examination will be without the aid of the Books.

- 3.2 <u>Computer and Skill Test (CST):</u> Computer and Skill Test (CST) involving Data Entry and Typing Test will be conducted. Only those candidates who qualify the Aptitude Test will be allowed to appear in the CST as per the Directorate letter No.F.No.34012/05/2018-DE datd 11.10.2018(Copy enclosed).
- 4. The crucial date for service eligibility condition for the following years of examination will be as under:

- 5. **No. of chances**: As per the Directorate letter No.60-10/2011-SPB-I dated 26-7-2011, the number of chances prescribed for General category is 8. In respect of SC/ST category, the number of chances is 10 provided there are vacancies reserved for candidates belonging to SC/ST and in case any SC/ST candidate is appointed on the basis of his/her 9th or 10th chance he/she shall be appointed against the vacancy reserved for SC/ST, as the case may be irrespective of his/her merit in the examination.
- 6. **Venues for conducting the examination**: The Examination will be conducted at Circle/Regional Head Quarters. The APS Candidates have to appear for the examination from the regional centre, to which they belong.
- 7. Photos: The applicant should enclose two passport size photos along with the application.
- 8. The schedule for conduct of the above examination is furnished in **Annexure IV**.
- 9. The PA/SA is a Divisional cadre, the year-wise vacancy position is furnished in **Annexure-1**, **II & III**, which may be circulated to all concerned. The vacancies notified are likely to vary/change without any prior intimation.

In case in any division, vacancies are not eventually identified and notified, the qualified candidates of that division will be treated as **surplus qualified candidates** and will be considered for allotment to divisions where there is shortfall to the extent of notified vacancies. The candidates may take up the examination in ENGLISH/HINDI.

10. **Application format:** The application format is enclosed. The controlling authority has to verify the details furnished in the Applications submitted by the candidates, thoroughly with reference to Name (as entered in the service records), Date of entry into service, Date of birth, category, eligibility criteria, etc. with reference to the relevant recruitment rules and service records of the concerned.

Based on the number of applications received/candidates permitted, the Regions will decide the Venue and to intimate the particulars to the Divisions and to the Circle Office to enable them to incorporate the particulars of the venue in the Hall Permits.
- 14. The application of the APS candidates should be sent to the concerned Divisions only and not to Circle Office.
- 15. The specimen form of appliation is enclosed. The application should be submitted in the prescribed form to the Divisions/Units in time. All officials including those on leave etc. should be informed of the examination without omission.
- 16. The Divisional Heads/Regional Heads/controlling authority are requested for circulating this notification immediately and to start the activity as per the notified schedule. The schedule should be adhered strictly.
- 17. The Divisional Offices have to verify the details thoroughly in the applications with reference to number of chances, category, date of birth, date of entry in feeder cadre, eligibility criteria with reference to regular service in feeder cadre etc. It is once again made clear that it will be the responsibility of the Regions/Divisions for ensuring that, the applications are properly checked, to see that the candidates have fulfilled the eligibility conditions and also filled the entries correctly relating to their date of birth, community, feeder cadre, examination centre with full address.
